### NOTICE TO EXHIBITORS

Dogs are required to have an ASCA Registration to enter this show. However, *as of January 1, 2003, ASCA requires registration of all non-ASCA registered dogs* in order to record and track these dogs for ASCA titles. If you wish to continue to have your qualifying scores recorded and receive ASCA titling certificates, you must register your dog and become a service member of ASCA at the time of registration. ### CLUB RULES FOR THE TRIAL

WSDC reserves the right to refuse an entry based on suitable causes only and in such instances, ASCA will be notified of the reasons. Every entrant must be in good standing with ASCA.  
All dogs must be on leash when not competing in the ring. Please clean up after yourself and your dog. Safety shall always be of foremost consideration in actions and conduct by handlers at all times.  
No entry will be refunded if the show cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee. There will be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal

Checks not honored by the bank do not constitute a valid entry. There will be a \$25.00 service charge for returned checks.
